## **October 14, 2021 – Select Board Meeting**

- 2) Selectboard approves prior meeting minutes and signs warrants
- 3) Tyler Adkins officially opens meeting to public comment

### **PUBLIC COMMENT**

Tyler Adkins stated that one warrant item, a check to Arvo Korsman needs further discussion and will be held back until resolved.

Richard Allard stated that the chip seal on the roads is not done, and the ditching and culverts have not been fixed. He stated that if the issues are not resolved within seven days, he will report it to the EPA.

Ricky Clawson asked if there will be further discussion regarding the selectboard by-laws. He feels that the change that Daniel made to the by-laws regarding research, was directed at Eric which is not fair. He agrees with Richard about the road work issues. Tyler stated that the by-laws are an open item and will be addressed and resolved.

John Moore feels that the road specifications given to the contractor were clear but that the job was not done properly. Dan Dube stated that the contractor should be sent a certified letter so there is documentation. Tyler asked for everyone's continued patience and assured the group that the issues will be resolved without further cost to the taxpayers.

Nick Fusco, owner of the Lakeshore House requested an extension of his liquor license to allow him to occasionally set up a tent on the ice and serve beer and food to snowmobilers. He is researching the possibility of adding this service to his restaurant and asked for input from the selectboard. Tyler suggested that he first apply for a permit and then go from there.

On behalf of the Narrow Gage Riders, Jacob Vainio requested help from the town to obtain grants for new equipment.
